Completion of Share Purchase Plan

Baraka Energy and Resources Limited (“**Baraka**” or “**The Company**”) wishes to advise that the Company’s Share Purchase Plan (SPP) closed on 26 September 2018 with applications received from eligible shareholders totalling \$785,000.

The board of Baraka is overwhelmed with the level of support shown for this SPP and will allow the company to pursue its strategic focus in the Vanadium sector.

Director Jason Brewer, geological and metallurgical technical consultants recently completed their on-site technical reviews and due diligence of a number of shortlisted projects in South Africa and the company will provide updates to its shareholders on the progress of these discussions and technical due diligence reviews.

The Board would like to thank its loyal shareholders for their continuing support of the Company.

The issue of new shares under the SPP offer is scheduled to occur on 28 September 2018 and holding statements will be mailed to all holders on 1 October 2018.

There has been significant interest in the shortfall shares under the SPP offer and post the Annual General Meeting, Baraka is confident it will place the shortfall shares to unrelated exempt investors utilising its Placement capacity.
